## ORDER:

Whereas, in the reference 2<sup>nd</sup> read above, Sri K. Ramu and Sri K.N. Srinivasa Rao, Assistant Executive Engineers (Civil) were promoted as Executive Engineers (Civil).

- 2. The above promotion order was issued subject to the following conditions:
  - (i) The promotions are liable for termination at anytime without notice and without assigning any reasons therefor.
  - (ii) The promotions are also subject to outcome of the W.P.No.16660 of 2015 and other court cases pending in the Hon'ble High Court of Judicature at Hyderabad for the state of Telangana.
  - (iii) The promotions are also subject to the finalization of allocation of employees between APTRANSCO & TSTRANSCO and subsequent change in the seniority, if any.
  - (iv) The promotions shall be reviewed after completion of the process of final allocation of cadre strength, vacancies and employees between successor States by the Government and persons so promoted meanwhile shall not have any right on such promotion.
- 3. Whereas, as per the Judgments of the Hon'ble Supreme Court in the references read above, the allocation of employees between APTRANSCO & TSTRANSCO has attained finality. As such, in the reference 9<sup>th</sup> read above, the "inter-se-seniority" of the Petitioners vis-à-vis the employees working in TSTRANSCO as on 02-06-2014 has been fixed and drawn. Consequently, the previous seniority of AEE(Civil) and EE(Civil) have undergone significant change necessitating review of the panels drawn earlier based on the said seniority. As a result, the promotion ordered for promotion from AEE(Civil) and EE(Civil) also be required to be re-drawn.

- 4. Therefore, the promotion ordered earlier from Assistant Executive Engineer (Civil) to Executive Engineer (Civil) has been re-drawn taking into consideration the "Inter-se-Seniority" now fixed as on 02-06-2014.
- 5. After careful consideration, the TSTRANSCO has decided to cancel the promotion ordered in the reference 2nd cited above, since the said promotion ordered therein was subject to the conditions as extracted at Para-2 above. Accordingly, the promotion ordered in respect of the following Assistant Executive Engineer (Civil) as Executive Engineer (Civil) is hereby cancelled with immediate effect:
