In the reference 3rd cited, the Director, Woodlands Hospitals, Barkatpura, Hyderabad has preferred (1) No. credit medical bill amounting to Rs.50,678/- (Rupees Fifty thousand Six hundred and Seventy Eight only) towards the medical treatment extended to Sri B.Sattaiah, OS/Retd, PPO No.10953 O/o. Pay Officer/VS/Hyderabad as in-patient for the period from 26-6-2018 to 3-7-2018 for "Surgery - TURP" at Woodlands Hospitals, Barkatpura, Hyderabad. In the ref. 4th cited, an amount of Rs.5,582/- was sanctioned. In the representation dt. 12-2-2018, the hospital authorities returned the original Cheque dt. 1-2-2019 for Rs.5,024/- and requested to reconsider the bill duly taking into consideration of Surgery and medical management done to the patient.

After careful examination and as per Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, the Chief General Manager (HRD) as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:1.10.2009, Memo dt. 28-7-2014 hereby accords a revised sanction for an amount of Rs.34,425/- (Rupees Thirthy Four thousand Four hundred and Twenty Five only) for reimbursement of medical charges to Woodlands Hospitals, Barkatpura, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.16,253/- (Rupees Sixteen thousand Two hundred and Fifty Three only) towards the excess amount claimed by Woodlands Hospitals, Barkatpura, Hyderabad over and above the CGHS rates.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.34,425/(Rupees Thirty Four thousand Four hundred and Twenty Five only) to Woodlands Hospitals, Barkatpura, Hyderabad against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.
- 4. An amount of Rs.29,223/- is sanctioned to Sri B.Sattaiah, OS/Retd, PPO No.10953 O/o. Pay Officer/VS/Hyderabad. A sum of Rs.5,202/- is recoverable from the pensioner. The Pay Officer/VS/Hyderabad is requested to recover the amount accordingly from the pensioner from his first pension towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the CGM (HRD)/TS Transco, within a month from the date of recovery from the first pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
