ORDER:

In continuation to the orders issued in the reference 4<sup>th</sup> cited, the Director, Yashoda Hospital, Somajiguda, Hyderabad was sanctioned with an amount of Rs.4,69,602/- (Rupees Four Lakhs Sixty Nine thousand Six hundred and Two only) against the credit of Rs.5,94,800/- (Rupees Five Lakhs Ninety Four thousand Eight hundred only) towards the medical treatment extended to Smt. G.Madhavi, W/o. Sri G.Sampath Kumar, ED(LIS)/TS Transco/VS/Hyderabad (I.D No.1046360) as in-patient for the period from 15-7-2020 to 25-7-2020 for “Bilateral Penumonia, Covid 19 (Medical Management)” at Yashoda Hospital, Somajiguda, Hyderabad.

2. In the ref. 5<sup>th</sup> cited, the Director, Yashoda Hospitals, Hyderabad has requested to sanction the total credit bill claimed by them duly taking into consideration of global pandemic of Covid times.

After careful examination and as per the minutes of CMD/TSTransco, under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and read with Memo dt.22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.1,25,198/- (Rupees One Lakh Twenty Five thousand One hundred and Ninety Eight only) to Yashoda Hospital, Somajiguda, Hyderabad in full and final settlement of credit bills towards the medical charges which were deducted towards the excess amount claimed by the Hospital.
