The Chief Engineer/Transmission/TSTransco vide references 2nd & 3rd cited has submitted approved note for payment of Annual Premium for renewal of Group Personal Accident Insurance Cover of Rs.50 Lakhs by M/s.National Insurance Company Limited for a period of One Year i.e. from 25.02.2024 to 24.02.2025 and requested sanction for payment of Annual Premium of Rs.2,14,462/- (including Medical Coverage and GST) for renewal of Group Personal Accident Insurance Coverage of Rs.50,00,000/- each (or) as per eligibility, whichever is less to 40 Nos.
