After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.03.2009 read with Memo dt.22-10-2020, the DS(HRD)/TSTransco hereby accords sanction for an amount of Rs.32,056/- (Rupees Thirty Two Thousand and Fifty Six only) from General Ceiling to Medicover Hospitals, Madhapur, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.350/- (Rupees Three Hundred and Fifty only) towards the excess amount claimed by Medicover Hospitals, Madhapur, Hyderabad.
