ORDER:

In the reference 3rd cited, the Director, Sunshine Hospitals (A Unit of Sarvejana Health Care Pvt. Ltd.), Secunderabad has preferred (2) No. credit medical bills amounting to Rs.1,97,275/- (Rupees One Lakh Ninety Seven thousand Two hundred and Seventy Five only) towards the medical treatment extended to Smt. M.Kanaka Durga, W/o. Late M.L.Nagabhushanam, Draughtsman/Retd, PPO No.9984, O/o. Pay Officer/TS Transco/VS/Hyderabad as in patient from 20-8-2019 to 28-8-2019 and from 1-9-2019 to 4-9-2019 for “Surgery: Left Total Knee Joint Replacement + Implants” and “Acute Gastritis, S/P TKR Medical Management + Other Supportive Care” at Sunshine Hospitals (A Unit of Sarvejana Health Care Pvt. Ltd.), Secunderabad and requested to issue in favour of Sarvejana Healthcare Pvt. Limited.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and vide T.O.O No.110, dt. 08-08-2016, the Joint Managing Director (Fin, Comml. & HRD) hereby accords sanction for an amount of Rs.1,97,275/- (Rupees One Lakh Ninety Seven thousand Two hundred and Seventy Five only) for reimbursement of medical charges to Sunshine Hospitals (A Unit of Sarvejana Health Care Pvt. Ltd.), Secunderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above.

3. The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.1,97,275/- (Rupees One Lakh Ninety Seven thousand Two hundred and Seventy Five only) to Sarvejana Healthcare Pvt. Limited, Secunderabad against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco/Vidyut Soudha/ Hyderabad.

4. An amount of Rs.1,95,730/- is sanctioned to Smt. M.Kanaka Durga, W/o. Late M.L.Nagabhushanam, Draughtsman/Retd, PPO No.9984, O/o. Pay Officer/TS Transco/VS/Hyderabad. A sum of Rs.1,545/- is recoverable from the pensioner. The Pay Officer/VS/Hyderabad is requested to recover the amount accordingly from the pension of the pensioner in instalments towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)/TS Transco., within a month from the date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
