#### ORDER:

In T.O.O under reference 1<sup>st</sup> cited, orders were issued for appointment of Smt.S.Shobha Rani, (who retired from services as Joint Secretary in TSTRANSCO on attaining age of superannuation on 31.10.2018 AN), as Officer on Special Duty to officiate as Convener to the Committee constituted for framing Service conditions and Regulations for Artisans, for a period of 6 months w.e.f., 01.11.2018 or until further orders whichever is earlier with a remuneration of Last pay drawn minus pension limited to Rs.1,00,000/-(Rupees One Lakh only) per month.

- 2. Accordingly, Smt.S.Shobha Rani, OSD along with the committee constituted for framing Service Conditions and Regulations for Artisans working in TS Power Utilities, has submitted Committee report duly framing the suitable Regulations governing the Service conditions of Artisans.
- 3. Subsequently, after completion of 1<sup>st</sup> tenure, in T.O.O.2<sup>nd</sup> cited, the services of Smt.S.Shobha Rani, OSD were extended as Officer on Special Duty, for a further period of four months with effect from 01.05.2019 to 31.08.2019 duly continuing the existing facilities, and remuneration which is to be borne by TSGENCO, for finalization of the compiled and updated Service Regulations of TSGENCO / TSTRANSCO.
- 4. As per the letter 3<sup>rd</sup> cited received from TSGENCO, the job of Service Regulations, Part-I, Part-II and Part-III is completed and the same is under printing. However, the Leave Regulations, D&A Regulations and O&M Regulations are yet to be taken up.
- 5. Taking into consideration the above and after careful examination of the matter, the services of Smt.S.Shobha Rani, Joint Secretary (Retd.), TSTRANSCO, are herewith extended as Officer on Special Duty for a further period of two months with effect from **01.09.2019 to 31.10.2019** so as to enable her to compile the above Regulations at an early date.

- 6. The remuneration i.e., Last Pay Drawn minus pension, limited to Rs.1,00,000/- (Rupees One lakh only) per month, paid by TSGENCO and other existing facilities shall be continued.
- 7. TSTRANSCO reserves the right to cancel/delete or alter any of the terms and conditions of the said appointment.
- 8. This order is issued with the concurrence of Joint Managing Director (Fin., Comml. & HRD), TSTRANSCO vide Regd. No.1966, Dt: 29.08.2019.
