**ORDER:**

In the reference 3<sup>rd</sup> cited, the Director, Krishna Institute of Medical Sciences limited, Minister Road, Secunderabad has preferred (1) No. credit medical bill amounting to Rs.64,938/- (Rupees Sixty four thousand nine hundred and thirty eight only) towards the medical treatment extended to Sri R.Ramdas, LM(Retd.), ID.No.1048074, O/o.SE/OMC/Metro-West/Hyderabad as in-patient for the period from 09.12.2020 to 14.12.2020 for “Surgery: Ileostomy Closure & Post Sigmoid Coloctomy” and requested to issue cheque in favour of Krishna Institute of Medical Sciences Limited.

After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TSTransco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 read with Memo dt.22-10-2020, the Chief General Manager(HRD) hereby accords sanction for an amount of Rs.64,938/- (Rupees Sixty four thousand nine hundred and thirty eight only) to Krishna Institute of Medical Sciences limited, Minister Road, Secunderabad in full and final settlement of credit bills towards the medical charges mention in para 1 above.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.64,938/- (Rupees Sixty four thousand nine hundred and thirty eight only) to Krishna Institute of Medical Sciences Limited against their credit bill under intimation to the Chief General Manager (HRD), Vidyut Soudha, Hyderabad.

4. An amount of Rs.52,555/- is sanctioned to Sri R.Ramdas, LM(Retd.), ID.No.1048074, O/o.SE/OMC/Metro-West/Hyderabad. A sum of Rs.12,383/- is recoverable from the employee. The SE/OMC/Metro-West/Hyderabad is requested to recover the amount accordingly in instalments from the pension of the pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco, within a month from the date of recovery from the pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
