ORDER:

In the reference 3rd cited, the Director, Care Hospital, Banjara Hills, Hyderabad has preferred (3) Nos. credit medical bills amounting to Rs.71,478/- (Rupees Seventy One thousand Four hundred and Seventy Eight only) towards the medical treatment extended to Sri B.Thimmaiah, OS(Retd), PPO No.10614 O/o. Pay Officer/VS/Hyderabad as in-patient for the period from 2-3-2018 to 5-3-2018, 24-3-2018 to 27-3-2018 & 9-4-2018 to 11-4-2018 for “Acute Decompensated HF with UTI Altered state for evaluation, B/L leg cellulitis K/c/o Left, hemiparesis DM, HTN, CKD and Urosepsis with acute febrile illness for evaluation hyponatremia, severe LV Dysfunction with sinus brady cardia R/o. Parksonisin T/A, K/c/o HTN, CAD S/p PTCA with moderate LV dysfunction CVA with Left hemiparesis, right leg cellulitis, CKD recurrent ADHF and Acute LVF with cardiogenic shock ADHF Precipitated by Urosepsis? DKA, AKI on CKD K/c/o DM, HTN, CAD with severe LV dysfunction Parkensonism” at Care Hospital, Banjara Hills, Hyderabad.

2. After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009 and vide T.O.O No.110, dt. 08-08-2016, the Joint Managing Director (Finance, Comm. & HRD) hereby accords sanction for an amount of Rs.63,601/- (Rupees Sixty Three thousand Six hundred and One only) to Care Hospital, Banjara Hills, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.7,877 /- (Rupees Seven thousand Eight hundred and Seventy Seven only) towards the excess amount claimed by Care Hospital, Banjara Hills, Hyderabad.

The Pay Officer/TS Transco/VS/Hyderabad is requested to arrange for payment of Rs.63,601/- (Rupees Sixty Three thousand Six hundred and One only) to Care Hospital, Banjara Hills, Hyderabad against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

4. An amount of Rs.53,299/- is sanctioned (Rs.15,494/- from General ceiling + Rs.20,410/- from SFMS for F.Y 2017-18 + Rs.17,395/- from SFMS for F.Y 2018-19) to Sri B.Thimmaiah, OS(Retd), PPO No.10614 O/o. Pay Officer/VS/Hyderabad. A sum of Rs.10,302/- is recoverable from the pensioner. The Pay Officer/VS/Hyderabad is requested to recover the amount accordingly from the first pension of the pensioner towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the Chief General Manager (HRD)TS Transco., within a month from the date of recovery from the first pension of the pensioner concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer.
